Dear Mr. Tafuni:

On June 22, 2016, at 11:34 am, a small leachate spill occurred at the Southeast County Landfill's Leachate Treatment Plant. Approximately 50 gallons of partially treated leachate spilled over the top of a tanker truck while being loaded outside of the facility's truck loading containment area. The spill was immediately contained on the impervious parking lot below using spill containment socks, and clean soil. The spill did not enter the adjacent stormwater pond or reach the surrounding grassy areas. Following containment, the soils and spill containment socks were removed and disposed of at the landfill's working face and the referenced parking lot was pressure washed.

The Solid Waste Management Division will provide written notification including corrective actions and photographs within 7 days as required by Permit No. 35435-022-SO/01.
