Thank you for your application for Waste Tire Processing Facility for the above referenced Facility. The application, DEP Application No. 0019600-010-WT-06, is considered complete. The Department will make every effort to issue the final agency action as quickly as possible.

On April 1, 2016, you applied for a small waste processing facility permit. The application was signed by you as applicant. On April 19, 2016, a Request for Additional Information (RAI) was sent. During our meeting on June 3, 2016, you decided that you would rather have a regular waste tire processing permit.

On August 24, 2016, Guerra Development Corporation (GDC) submitted on your behalf a Waste Tire Processing Facility Application for Friends Recycling, L.L.C. The application was signed by Gerald Lourenco on August 24, 2016 as the applicant. Juan C. Guerra, P.E., of GDC signed and sealed the application on August 24, 2016 as the Engineer of Record. A revision to the application was received on September 20.2016. It included responses to DEP's RAI dated April 19, 2016.

The Department approves the closure cost estimate for the Waste Tire Processing Facility of \$6,000.00. This cost has been added to the last closure cost estimate approved by the Department on February 9, 2016. It is shown on the Closure Cost Estimating Form signed,

sealed and dated August 24, 2016 by Juan C. Guerra, P.E. The Department approves the facilitywide closure cost estimates of \$1,193,081.20 for closing and \$347,571.97 for a total of 5-year long-term care for C&D (26.8 acres). (Long-term care is not necessary for a closed waste tire processing facility.)
