Subject: Hurricane Matthew Clean UP

Alan,

I understand that the Vista Landfill on Keene Rd made it through the storm in good condition and is open for regular work. The City was lucky that storm damage was not severe but we have determined there is significant tree and other vegetative debris to be cleaned up.

The City has engaged AshBritt to collect and direct haul this debris to approved locations to supplement the capacity of City's own crews. The City will pay the regular contract rate per ton for this clean yard waste, bagged, bundled or loose, delivered to Vista. These trucks will have placards that say AshBritt and an ORL 100 or 200 series number for billing purposes. We plan to haul from 0700 to 1700 hours Monday through Saturday and hope this collection will take about one week. These AshBritt placarded trucks will be <40 yard grapple trucks (claw) and 16 to 24 CY dump trucks.

The ORL 100 series trucks will be billed to the Solid Waste Division and the ORL 200 series trucks will be billed to the Streets and Stormwater Division. Detailed account numbers are available from Diane Horner.

Please let me know that you have received this and if you have any questions or concerns. Thanks in advance for the assistance of WMI as we clean up from this storm.
