Thank you for your application for Solid Waste Operation Permit for the above referenced Facility. The original permit application was dated December 14, 2016 and received on December 20, 2016. A request for additional information (RAI) was issued on January 6, 2017, and the RAI response was received on January 6, 2017. The application, DEP Application No. 0310464-002-WT, is considered complete. The Department will make every effort to issue the final agency action as quickly as possible.

Your RAI response submittal included an updated Financial Assurance Cost Estimate that included the costs to load and transport tires from the Consolidated Tire Processing, LLC, Waste Tire Processing Facility. The revised total cost estimate, as stated in the estimate, is \$8,904 (\$0.89 per tire). The cost estimate is approved by the Department.

The documentation to demonstrate financial assurance must be sent to Susan Eldredge, FDEP Solid Waste Section, MS-4565, 2600 Blair Stone Road, Tallahassee, Florida 32399.

You are reminded that you must submit an annually-adjusted closing cost estimate at least 60 days prior to the anniversary date of the financial assurance mechanism, in accordance with Rule 62-711.500(3), F.A.C. In this case, the annual cost estimate is due by October 8th each year (original financial assurance bond was submitted on December 8, 2016). The 2017 cost estimate adjustment must be sent to the Central District not later than 10/8/2017.
