The Facility has received a large volume of rainfall in the past week ((Friday 8/25 0.8"; Saturday 8/26 4.5"; Sunday 8/27 1.3"; Monday 8/28 0.23" and Tuesday 8/24 0.30" – Total of 9.1 inches). The Facility has additional hauling contractors taking leachate offsite. However, to provide additional onsite storage capacity, leachate and/or the collected runoff from the Compost Facility is being diverted to Pond B. As capacity is recovered in the leachate tanks, the diverted liquid in Pond B will be removed and sent to the tanks or truck-loading station(s).

In accordance with the Leachate Management Plan, Section 8.2, the County is providing this notification of the use of Pond B to FDEP.
