Dear Mr. Marion:

Under Section 403.815 of the Florida Statutes and Rule 62-701.320(8)(a) of the Florida Administrative Code, you (the applicant) are required to publish at your own expense the enclosed Notice of Application. The notice must be published one time only within 14 days of receipt of this letter, or if your application is not yet complete, within 14 days of submittal of a complete application. The notice must be published in the legal ad section of a newspaper of general circulation in the area affected. For the purpose of this rule, "publication in a newspaper of general circulation in the area affected" means publication in a newspaper meeting the requirements of section 50.011 and 50.031 of the Florida Statutes in the county where the activity is to take place. Where there is more than one newspaper of general circulation in the county, the newspaper used should be one with significant circulation in the area that may be affected by the permit. If you are uncertain that a newspaper meets these requirements, please contact the undersigned at the address or telephone number listed below.

The applicant must provide proof of publication to the Department, at the Department of Environmental Protection, 3319 Maguire Boulevard, Suite 232, Orlando, FL 32803-3767, telephone (407) 893-3328, within seven days of publication. Failure to publish the notice and provide proof of publication within the allotted time may result in the denial of the permit.

The Department announces receipt of an application for permit modification from Volusia County Solid Waste Department, 3151 State Road 44, DeLand, FL 32724, to modify the existing Class III landfill operation permit and to construct an 8-acre lateral expansion and a 32.2 foot vertical expansion, to the existing Class III cell at the County's Tomoka Farms Road Landfill for the disposal of Class III waste. This proposed project will be located at 1990 Tomoka Farms Road, south of Interstate 4, west of Interstate 95, and southwest of Daytona Beach, in Volusia County, Florida.

This application is being processed and is available for public inspection during normal business hours, 8:00 a.m. to 5:00 p.m., Monday through Friday, except legal holidays, at the Department of Environmental Protection, 3319 Maguire Blvd., Suite 232, Orlando, FL 32803-3767, telephone 407-893-3328. Any comments or objections should be filed in writing with the Department at this address. Comments or objections should be submitted as soon as possible to ensure that there is adequate time for them to be considered in the Department decision on the application.
