Thank you for your application for Waste Tire Processing Facility for the above referenced Facility. The original permit application was dated April 27, 2018 and received April 30, 2018. The application, DEP Application No. 0136808-007-WT, is considered complete. The Department will make every effort to issue the final agency action as quickly as possible.

Your application submittal included a "Closure Cost Estimating Form 62-701.900(28)" for the Global Tire Recycling of Sumter County, Inc.. The document included calculated estimated closing costs for the facility which included the costs for pick up, hauling and disposal of 1,200 tons Waste tires and processed tires and 235 tons of Residuals.

The total closing cost estimate provided in the Cost Estimate Form for the above is estimated to be \$82,590.

The most recent document to demonstrate financial assurance for the facility was for the amount of \$81,469.58 as stated in the letter from the Department dated February 16, 2018. The cover letter stated the current balance of the trust fund was \$82,803.07, therefore, no action is required at this time for the financial mechanism.
