On behalf of the Public Works Department Solid Waste Management Division, we are pleased to submit the Analytical Data Report for the Supplemental Sampling Event conducted at the Southeast County Landfill on August 2-3, 2017. Representative samples were collected from the eight monitoring wells, TH-20A, TH-38B, TH-66A, TH-67, TH-79, TH-80, TH-81, and TH-82 to evaluate the impacts to groundwater in the area east of Phase II. In accordance with the Consent Agreement OGC File No. 17-0058 and the associated Corrective Action Plan, these sampling events will be conducted on the required quarterly basis, and the reports will be submitted to you electronically.
