

This letter is to acknowledge receipt of cost estimates, dated and received August 3, 2018, for the closure of Day and Night Tire, LLC. Pursuant to rule 62-711.500(3), the below is a calculation for cost to close the subject facility including transport and disposal. Proof of financial responsibility is also provided.

Dear Matt,

I am pleased to provide this proposal as follow up to our previous discussion. As I indicated, Liberty Tire Recycling is prepared to load, transport, process and dispose up to 100 tons in the event of site closure. This proposal pertains to whole passenger tires and truck tires but does not cover off road tires (forklift, tractor, loader, grader etc.).

- The cost to load, transport, process and dispose would be One Hundred thirty dollars (\$130) per ton. Please note that this proposal covers the entire cost of handling the subject tires.
