On behalf of CEMEX Construction Materials Florida, LLC, Koogler and Associates, Inc. is submitting this request for a minor modification to the CEMEX Brooksville South Waste Tire Processing Permit No. 22787-005-WT. The current permit expires on January 19, 2023.

CEMEX is proposing to move the storage location of the outside trailers. Attached is a copy of the updated site plan showing the new storage location. The revised site plan as well as a revised Operations Plan was requested by the Department per email from Emily Wargo on October 29, 2018. However, in review of the Operations Plan, the change in storage location does not affect the Operations Plan, therefore it is not enclosed and remains as currently permitted.

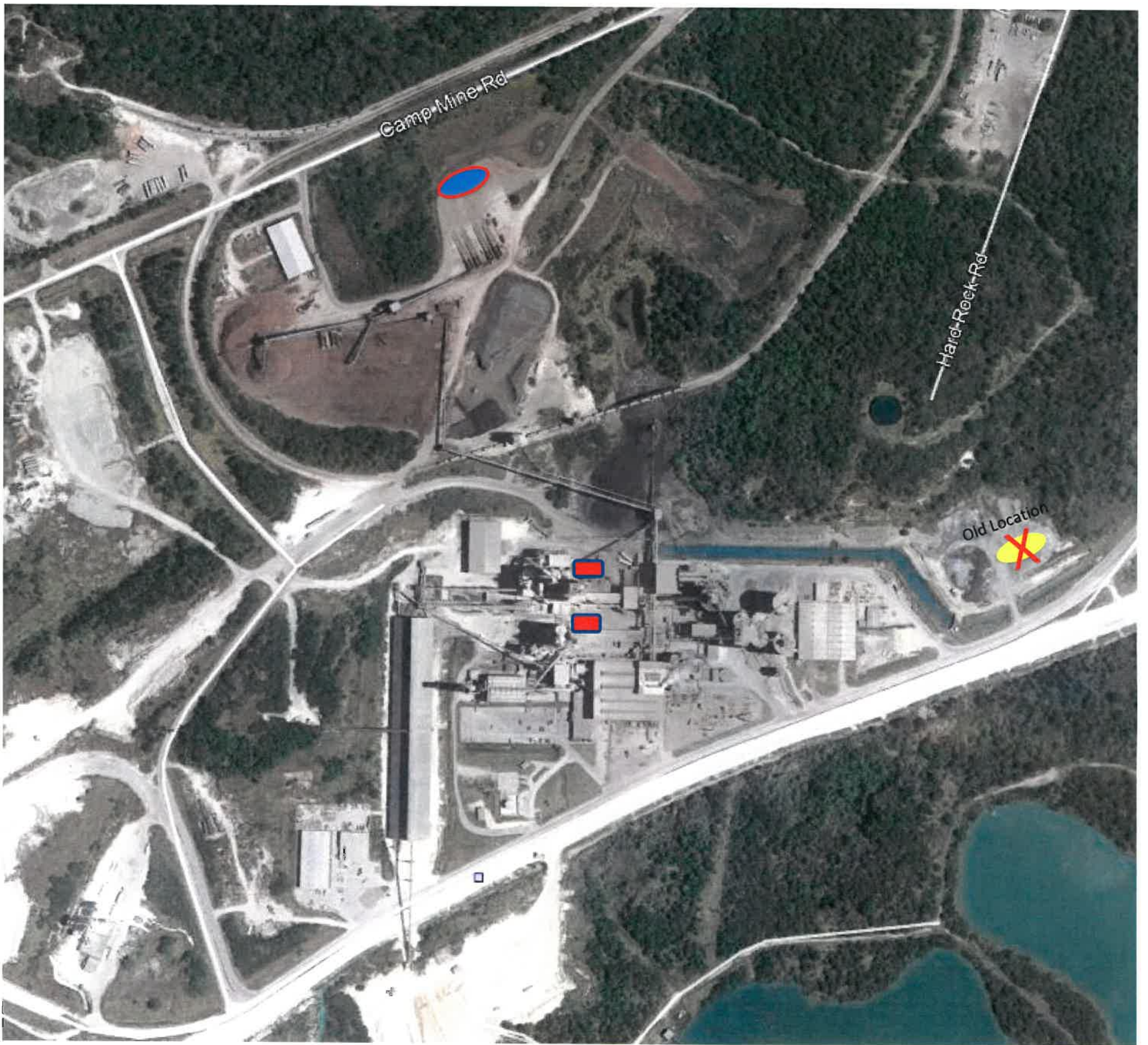


