Re: Notification of Abandonment – Series I Piezometers  
Southeast County Landfill  
Hillsborough County, Florida

As discussed earlier, we have obtained a schedule from SCS Engineers for the abandonment of all of the Series I Piezometers within the Phases I-V disposal areas.

SCS will subcontract with Ambient Technologies, Inc. (ATI) who will be performing the abandonment. All Series I piezometers (except SB-29, -30, -32) will have the 2-in PVC pipes, and the open borehole around the pipes, grouted with a water/bentonite mix from the bottom of piezometer to ground surface.

ATI is scheduled to be onsite the week of Nov 5-9 to complete the work.

Once the work is complete, a short letter report w/ a copy of permit and well abandonment logs, will be forwarded to FDEP.
