SCOPE OF WORK

This *estimate* is for budgeting the future removal of \sim 4,000 unprocessed and \sim 2,000 processed passenger tires from the 2203 Hamilton Street facility located in Duval County, Florida. The *estimate* assumes the use of a grapple truck, or similar, loading and hauling the tires to a state approved tire disposal facility.
