SUBJECT: Inflation Adjusting Cost Estimates for Escrow Account Users

It is time for owners and operators of solid waste management facilities using a landfill management escrow account to inflation adjust facility closure cost estimates. If you have already submitted your cost estimate update for 2019, please disregard this notice.

Pursuant to [Rule 62-701.630\(4\)\(a\)](#), Florida Administrative Code, cost estimate adjustments must be made every year* between July 1 and September 1. The new inflation-factor is **1.022**.

The cost estimate form is available online and at DEP Offices:

Remember, if you are adjusting your estimate using the current inflation factor (**1.022**), submit only the first two pages of [Form 62-701.900\(28\)](#).
