Good Afternoon Cory,

Per our conversation yesterday, I wanted to clarify, and confirm, that we (Hillsborough County) do not intend to physically "tie in to the Hypalon along the toe of the landfill....." as implied in Bullet Number 5 of the Memo of Understanding.

Our intent would be to design a sideslope closure system that can be installed "over" the sideslope bottom liner (comprising of a Hypalon liner material) and to anchor beyond (outside of) the Hypalon liner. This will insure the integrity of the Hypalon is maintained and due to the age of the material and the material's composition, it would be very difficult to "physically attach to, and or repair, the Hypalon should it become damaged. The proposed closure system will be designed to seal (possibly with a GCL) any gaps between the sideslope closure system and the Hypalon. We will provide a closure detail showing the placement of the closure system relative to the Hypalon liner.
