Dear Ms. Montgomery:

Thank you for your application for a Class III operation renewal with vertical expansion submitted on August 5, 2019 for the above referenced Facility. A review of your application and supporting documentation indicates the application is incomplete. Please provide the information listed below and refer to this RAI in your response. The response to this RAI must be signed, sealed, and dated by a registered Florida Professional Engineer.

1. **[Volume I, Electronic Document p. 59]** Application, Section 3.13, p. 3-3. Provide proof of publication in a newspaper of general circulation regarding the permit modification. Regulation reference: Paragraph 62-701.320(8)(a), F.A.C.
2. **[Volume I, Electronic Document p. 59]** Application, Section 3.13, p. 3-3. Provide proof of notice of application to the Chair of the Board of County Commissioners, highest ranking elected official of the municipality, and each State Senator and Representative serving the jurisdiction in which the facility is located. Regulation reference: Paragraph 62-701.320(8)(b), F.A.C.
3. **[Volume I, Electronic Document p. 83]** Application, Section 13.2, p. 13-1. Regarding waste relocation and the proposed stormwater ditch construction:
  - a. Identify the location of the proposed waste to be relocated and the associated proposed ditch(es).
  - b. Indicate the proposed depth of waste to be removed as part of the ditch construction and clarify whether any dewatering is anticipated.
  - c. Verify that any leachate generated from the waste relocation/ditch construction would be managed properly.
  - d. Verify that any hazardous waste encountered during the waste relocation would be managed in accordance with Chapter 62-730, F.A.C.

- e. Verify that the remaining in-place waste would be covered with at least two feet of soil.
- f. Confirm that the FDEP Central District Office would be notified at least seven days prior to the start of waste relocation.

Regulation reference: Paragraph 62-701.610(2), F.A.C.

- 4. **[Volume II, Electronic Document p. 18]** Drawings, Drawing CD-1, Detail 4. Revise the detail to show 24" of soil cover over the ditch GCL, which will be placed over waste, rather than 12" as specified. Regulation reference: Paragraph 62-701.600(3)(g)3, F.A.C.

To continue the processing of your application, the Department must receive a response within 90 days of this letter, November 10, 2019, unless a written request for additional time to provide the requested information is submitted and approved. It is the Department's desire to provide prompt turnaround times on permit applications, and a quicker response to this RAI shortens the timeframe for which a final decision on the application can be made. Pursuant to Rule 62-4.055(1), F.A.C. and Section 120.60, F.S., failure of an applicant to provide timely requested information by the applicant deadline may result in denial of the application. You are encouraged to contact this office to discuss the items requested to assist you in developing a complete and adequate response.
