

Please work with the Solid Waste Financial Coordinator in Tallahassee directly to assess compliance with the funding mechanism requirements.

The Department requests a response within 30 days of the date of this letter, November 10, 2018. Pursuant to Rule 62-4.055(1), F.A.C. and Section 120.60, F.S., failure of an applicant to provide the timely requested information by the applicable deadline [90 days from the date of this letter] may result in denial of the application, unless a written request for additional time to provide the requested information is submitted and approved.
