This letter is to acknowledge receipt of inflation-adjusted cost estimates, dated December 12, 2019 and received December 17, 2019, for closure of the US 27 Tires Waste Tire Processing Facility. The cost estimates received December 17, 2019 (total for closing \$5,416.60) are **APPROVED for 2019**. This estimate is for disposal of **5,300 tons of waste tires**. The next annual cost estimate is due at least 60 days prior to anniversary of the financial assurance mechanism. There has been no change in the above referenced facility concerning waste tires storage, and the facility is operating in compliance with the permit requirements. The maximum number of tires that can be stored onsite is 5300 tires. The anticipated disposal cost for the maximum storage quantity is calculated as follows:

2018 Disposal Cost Estimate = \$5300.00

FDEP Inflation Multiplier 2019 = 1.022

2019 Disposal Cost Estimate $\$5300.00 \times 1.022 = \5416.60
