Dear Mr. Chewning:

In response to the request submitted on November 30, 2006, Permit Nos. SC48-0165969-010 and SO48-0165969-011 are modified to incorporate the minor infrastructural layout changes associated with the future operation activities at the above referenced landfill. This includes modification of the following items: (i) site entrance layout, (ii) scale-house layout and location, (iii) landfill perimeter roads, (v) associated storm water ponds, (vi) addition of a customer drop-off area, and (vii) addition of a temporary entrance ramp for haul truck access to the filling area. The changes to the layout were incorporated to improve access into the site, minimize traffic congestion, and improve safety along West Keene Road.

An updated Monitoring Plan Implementation Schedule (MPIS) is attached as Exhibit I.

The information submitted on November 30, 2006, and January 8, 2007, on file at the Central District office, is made part of the subject permit. The documents are listed in Attachment A.

All other conditions of the subject permits remain unchanged.

This letter must be attached to Permit Nos. SC48-0165969-010 and SO48-0165969-011 and becomes part of that permit. The new Permit No. is SC48-0165969-012.
