This letter is to acknowledge receipt of inflation-adjusted cost estimates, dated and received February 27, 2020, for closure of the CEMEX Brooksville South Cement Plant Alternative Fuel Material Processing Facility. The cost estimates received February 27, 2020 (total for closing \$331,311.82) are **APPROVED for 2020**. This estimate is for disposal of 5200 tons of alternative fuel material. The next annual update (revised or inflation-adjusted estimates) is due no later than **March 1, 2021**.


Dear Mr. Ramirez:

The above referenced facility was issued Permit No. 22787-006-SO/31 on December 17th, 2018. There are no changes regarding the management of alternative fuels. The facility is operating in compliance with the permit requirements. The maximum quantity of alternative fuel storage is 5200 tons. The anticipated disposal cost for the maximum storage quantity is calculated as follows:

2019 Disposal Cost Estimate = \$324,179.86
FDEP Inflation Multiplier **2020 = 1.022**
2020 Disposal Cost Estimate (1.022 x \$324,179.86) = \$331,311.817
Current Bond Amount - \$350,000, Travelers Bond No. 106077080
