Dear Mr. Fannell:

This letter is to acknowledge receipt of new cost estimates, dated December 14, 2020 and received January 11, 2021, for closure of Tire Shredders of America Waste Tire Processing Facility. The cost estimates received January 11, 2021 (total for closing \$15,000) are APPROVED for 2021. This estimate is for disposal of 120 tons of waste tires. The next annual cost estimate is due at least 60 days prior to anniversary of the financial assurance mechanism.
