Today, February 19, 2021, Hardee County experienced a release of landfill leachate beyond the limits of the liner and secondary containment system. The County took immediate action by turning off switches and berming the area with clean dirt. Doing so, the County was able to contain the water to just outside of tank 2 before making its way to the nearby ditch. Photos were taken of the area and are provided below.

Hardee County plans to do follow up soil testing and groundwater sampling from the affected area. If you have any questions or have further requirements, please advise.
