As of today, we have not been able to secure a contractor to complete the repair work. I have reached out to another company suggested by SCS Engineering and am waiting to hear back from them. In the meantime, I am going to reach out to the Public Works Director and County Manager and try to come up with some alternative solutions in the event that they are not able to help.

We have contracted SCS Engineering who will be performing the necessary soil testing. We are awaiting the specific parameters, but once we have those it will be completed as soon as possible. SCS will also be performing a tank inspection, as the last one looks to have been done in August of 2017.
