The Environmental Permitting Section (EPS) of the Department of Regulatory and Economic Resources-Division of Environmental Resources Management (DERM), under delegation by the Florida Department of Environmental Protection (FDEP), is in receipt of the referenced cost estimate on April 8, 2021. DERM has completed the review of said estimate and hereby approves it in the amount of **\$61,780.30**.
