On behalf of Titan America, Koogler and Associates, Inc., is submitting the enclosed annual cost estimate update for the Titan America Pennsuco Tire Processing Facility as required by permit 0314354-002-WT, Section 2. B. G. 2 - Annual Cost Estimates and Chapter 62-711.500 F.A.C., Waste Tire Site Notification and Requirements.

Enclosed with this submittal are the following documents:

- Closing cost estimate signed and sealed by a Florida licensed Professional Engineer; and
- Third Party Estimate from Liberty Tire.

The third-party estimate from Liberty Tire was provided for another cement plant in Miami for their prior closing cost estimates in 2019. This same estimate was provided for the Titan 2019 and 2020 closing cost estimate update and was subsequently approved by Miami Dade County Department of Environmental Resource Management and the Florida Department of Environmental Protection (FDEP). Koogler has been unable to locate a third party that is willing to continue to provide these estimates. Therefore, the FDEP inflation factor for September 2021 was used to update the third-party estimate obtained from Liberty Tire in 2019. In 2019, the FDEP informed Koogler that using the inflation factor was acceptable.

This updated closing cost estimate is \$38,595.15, which is less than the current Guarantee Bond secured by a Trust Fund Agreement – Bond Rider of \$43,000 which became effective on November 1, 2020.

I hereby confirm that the quantity of waste tires at the site has been verified to be within the quantity limits (maximum of 300 tons) as stipulated in the facility's existing FDEP Permit No. 0314354-002 and that the estimate is based on said permit limits.
