On behalf of American Tire Recycling Group, LLC Wood is submitting an inflation adjusted closure cost estimate for approval of the 2022 Financial Assurance requirements for the subject facility. The breakdown of the inflation adjustment for 2022 is provided as follows:

The initial basis of this inflation adjusted estimate is the itemized closure cost estimate submitted on 06/30/2020 and approved by DERM on 07/10/2020, which provides a breakdown of the costs to load, transport and dispose of the maximum quantities of waste tires stored at the site that are subject to financial assurance requirements.

Pursuant to rule 62-711.500(3), F.A.C., I certify that the quantity of tires stored at the facility does not exceed the maximum permitted quantity of 1,124 tons for the aggregate of whole and processed waste tires (including used tires) as referenced in the latest FDEP permit issued to the site.
