Mr. Istambouli:

Per the requirements of the Miami-Dade County Department of Environmental Resource Management, CEMEX Construction Materials of Florida, LLC is providing this closing cost estimate for the cost to remove, process and dispose of the maximum amount of waste tires stored at the facility at any time. The purpose of this submittal is to fulfill the requirements of Rule 62-711.500(3) F.A.C., to provide a re-estimate of the annual closing costs for waste tires.

The estimated cost to remove, process and dispose of the maximum permitted amount of waste tires stored at the facility at any time (30,000 tires, or 300 tons) is:

$$300 \text{ tons @ } \$150/\text{ton} = \$45,000 \times 1.012 = \underline{\$45,540}$$

This cost estimate is based on a third-party quote provided by Liberty Tire Recycling, dated February 25, 2021 (attached) and the 2022 inflation factor of 1.012 provided by FDEP Division of Waste Management.

I hereby confirm that the quantity of waste tires at the subject facility site has been verified to be within the quantity limits (300 ton maximum) stipulated in FDEP Permit 0146251-008-WT.

Dear Mr. Hogg,

I am pleased to provide this proposal as follow up to our discussion of Friday, February 19th. As I indicated, Liberty Tire Recycling is prepared to load, transport, process and dispose of up to 300 tons of whole tires in the event of site closure. This proposal pertains to whole passenger tires but does not cover off road tires (forklift, tractor, loader, grader etc.).

- The cost to load, transport, process and dispose would be One Hundred fifty dollars per ton. Please note that this proposal covers the entire cost of handling the subject tires.
