We reviewed the groundwater sampling logs from the Lena Road Landfill second semiannual sampling event conducted in November 2022. It was noted that dissolved oxygen readings were not less than 20% nor within the secondary criteria of +/- 0.2 mg/L at monitoring wells GW-4, GW-9, and GW-20, prior to collecting groundwater samples for lab analysis. This issue was discussed again with the lab and these three wells will be resampled on Thursday, 12/29. Please let this serve as our notification of groundwater sampling activities at the Lena Road Landfill.
