All –

It appears as though there is a question (or dispute) between Webber Recycling (facility operator) and Hamilton Development (facility landowner) regarding the payment of the costs associated with the clean-up and disposal of the waste tires at the Webber Recycling facility at the time Webber ceased its operations.

The Department's primary responsibility is to ensure that regulated facilities are properly operated/maintained and that regulated materials are disposed of properly. What entity pays for disposal or maintenance is not the Department's concern. Therefore, because the former Webber Recycling facility ceased operations and all waste tires at the site were removed and disposed of properly, the Department will be closing its file on this matter and will not take any further action with regard to collecting the cost of clean-up from Webber.
