Final Certification of Construction Completion for Cell 1

Dear Mr. Slike:

The liner installation was inspected on September 19, 2008 and the remaining portion of the leachate collection system was inspected on November 14, 2008. Based on those inspections and the documents submitted, the Department approves the Certification of Construction Completion for Cell 1 at Vista Landfill. The following documents are made a part of this approval:

1. "Certification of Construction Completion of a Solid Waste Management Facility" [DEP Form 62-701.900(2)] and "Final Certification Report for the Construction Quality Assurance Services," for Vista Landfill, LLC. Both documents were signed and sealed by Juan Quiroz, P.E. of Geosyntec Consultants, on September 11, 2008. The certification was for the construction of the liner system and leachate collection system in Cell 1. The certification for the leachate collection system ends at the manhole located south of the leachate storage tank area. Also, the certification did not include construction of ancillary items (i.e., surface water runoff drainage system, access roads, etc.).
2. "Review of Certification of Construction Completion for Cell 1 Liner System and Part of the Leachate Collection System," DEP Letter OCD-SW-08-0476, dated September 22, 2008.
3. "Response to Comments, Final CQA Report for Cell 1 Constr at Vista LF," e-mail from Juan D. Quiroz, P.E. of Geosyntec Consultants, dated October 8, 2008. The e-mail had an attachment titled "Response to Request for Additional Information dated 23 September 2008 Final Certification Report for Construction Quality Assurance Services Vista Landfill, Class III – Cell 1 Construction Apopka, Florida (Permit Nos. SC48-0165969-014 and SO48-0165969-015)," dated October 8, 2008. This correspondence answered the comments 1 thru 4 raised in DEP Letter OCD-SW-08-0476, dated September 22, 2008.

4. "Vista Leachate System Certification of Construction," e-mail from Sheree Grant of Waste Management Inc, dated November 8, 2008. The e-mail had an attachment titled, "Certification of Construction Completion for Cell 1 Pump Station, Force Main Section from Manhole to Truck Load Out, Tank and Pump Station," dated November 7, 2008. The certification was signed and sealed by Raymond J. Chewing, P.E. on November 7, 2008. The certification was for the construction of "Cell 1 pump station, FM section from manhole tom truck load out, tank & pump station."

(NOTE: There was a mistake on the As Built Drawing titled "Leachate Management System Mechanical Flow Diagram As-Built." A valve needs to be shown in the upper left between "manhole" and "To Leachate Storage Tanks." Please submit a corrected drawing.)

5. "Permission to Accept Waste at Vista Landfill Cell 1," e-mail from Tom Lubozynski dated November 14, 2008.
6. "Specific Condition #21 Has Been Met," e-mail from Tom Lubozynski dated December 12, 2008. Ms. Sheree grant had provided a report from Florida JetClean documenting the cleanout of the leachate collection system as required by Specific condition #21. This e-mail acknowledged condition #21 has been met.

Neither this letter nor any prior agreement with the Central District Waste Management Program relieves you of the responsibility of complying with any applicable ordinances, rules, or laws of any local, county, state, or federal government entity. Vista Landfill must complete the leachate handling system; this includes an industrial wastewater permit the Central District. Notify us when you receive the industrial wastewater permit. Also, the City of Apopka has separate permitting authority.
