The intent of this letter is to notify the Department of the completion of the initial Semi-Annual Groundwater Sampling Event in accordance with Permit No. PA 87-23 which was conducted during the period of April 25th-27th, 2023. The initial laboratory results for this sampling event, which were received on May 31st, 2023, indicated that two wells showed parameters at levels above water quality standards. Per 62-701.510(6)a F.A.C., the County is electing to resample these wells in order to confirm the initial results. Additionally, a number of other wells were resampled due to handling issues encountered at the testing laboratory. Resampling was conducted on June 27th and 28th, 2023 within the 30-day window allowed for resampling. The County is currently awaiting the finalized laboratory report from the resampling and will submit to the Department the complete Semi-Annual Groundwater Monitoring Report, including discussion of the resampling activities, within 60 days of receipt of the finalized resampling laboratory results.
