Dear Mr. Massaro:

In response to the intermediate permit modification request submitted January 7, 2005, the Department is granting your request to operate the Taft Recycling, Inc. Waste Processing Facility for temporary acceptance of Class I municipal solid waste (MSW).

Specific Conditions 32 and 33 are added to Permit No. SO48-0173968-004:

32. <u>Existing MRF Building Upgrades</u>: Class I MSW cannot be accepted into the existing MRF building until it has been retrofitted with upgraded ventilation, lighting and leachate controls. This construction must be certified by the professional engineer of record, and accepted by the Department before Class I solid waste is received.

33. <u>Temporary Class I Operation Duration</u>: Approval for the temporary Class I operation will remain in force until the additional new construction of permanent facilities previously authorized under DEP Permit No. SO48-0173968-004 has been completed, certified by the professional engineer of record, and accepted by the Department. The estimated time to complete and certify construction is six months.

The information submitted on file at the Central District office is made a part of the subject permit and is listed in Appendix A.

All other conditions of the subject permit remain unchanged.
