Approval of Closure Cost Estimates

Dear Mr. Contestabile:

The Department has reviewed the document "Closure Cost Estimating Form for Solid Waste Facilities" submitted for Empire Tire of Edgewater, LLC. dated July 28, 2010. The document was signed by you. The inflation adjustment factor of 1.02 was used to calculate the closure cost estimate. The closure cost is estimated at \$42,075.00 and is acceptable to the Department.

Please note, according to Rule 62-711.500(3) which states in part that the cost estimate shall be reestimated at least annually and submitted to the Department at least sixty days prior to the anniversary date of the instrument (financial assurance). The initial date of your financial instrument was June 6, 2008. Based on this rule quoted above the updated cost estimate [DEP Form 62-701-900 (28)] must be submitted to the Department Central District office for approval by April 6, of each year. The next updated cost estimate submittal is due on **April 6, 2011.** 

The documentation to demonstrate financial assurance must be sent to Frank Hornbrook, FDEP Solid Waste Section, MS-4565, 2600 Blair Stone Road, Tallahassee, Florida 32399. In order to be in compliance, you must submit the financial assurance documentation by **June 6** of each year starting in 2011. For this year the deadline to submit the updated financial documentation is **September 26, 2010**.
