

## GENERAL GUIDELINES

This document provides general guidelines and definitions for Florida's Outdoor Recreation Inventory (FORI).

**Unit Name:** Formal name of managed area.

**Primary Agency:** Agency that manages the area.

**Category:** Type of provider (Federal, State, County, Municipal, Non-Profit, Special District, Commercial, and Club)

**Address:** Physical location of the area.

**Agency Mailing Address:** Address of the agency.

**Unit County(ies):** Includes all of the counties the area is located in.

**Location Information:** Additional information on the physical location of the area.

**Sit Name:** The name of a recreation area within another recreation area. If a recreation has a site within it an additional site sheets is needed.

**Site County:** The county of the specific site sheets. A site sheet is needed for each county if an area is located in multiple counties.

**Latitude and Longitude:** Coordinates should be noted in degrees and seconds or decimal degrees.

**Grant Program:** The grant program that has funded the part or all of the acquisition of the area or the development of facilities.

**Resource Class:** The type of recreation area. Please see the Table 1 for a listing of the recreation area types.

## Resources and Facilities

**Acres:** Acreage should include all developed and undeveloped acreage. Please make sure that the sum of land and water acreage equals the total acreage.

**Hunting:** Please make sure that the sum of land and water acreage equals the total acreage

### Overnight Facilities

**RV/Trailer Sites:** Number of campsites for recreational vehicles or trailers.

**Tent Sites:** Campsites used only for tent camping.

**Cabins:** Cabins available for overnight use.

**Primitive Camping:** Camping areas with limited, if any, facilities. (Report total acreage designated for use).

**Primitive Tent Campsites:** Campsites w/limited, if any, facilities.

**Equestrian Campsites:** Campsites designed and intended for accommodating equestrian riding users.

### **Picnic Facilities**

Tables: Picnic tables

Shelters: Picnic shelters

### **Cultural Resources**

**Museums/Interpretive Buildings:** Facilities without intrinsic historical or archaeological value, built to provide Interpretive displays, exhibits or programs.

**Archaeological/Historic Sites/Structures:** Number of fortifications, battlefields, ruins, burial mounds, etc., with intrinsic historical or archaeological value.

**Commemorative Structures:** Structures or monuments (do not include signs, plaques, or markers).

### **Trails**

**Single Use:** Trails with one intended or designed use.

**Multiple Use:** Trails that can accommodate more than one use.

**Trailheads:** Developed points of entry to a trail usually associated with restroom facilities, parking areas, parking spaces, and kiosks.

### **Trail Activities:**

**Hiking:** Walking short or long distances on a trail, include backpacking.

**Florida Trail System:** Single use Hiking trails designated by the Florida Trail Association.

**Florida National Scenic Trail:** Single/Multiple use trails federal certified as part of the Florida National Scenic Trail.

**Bicycle - Paved:** Use of a nonmotorized bicycle on a paved trail.

**Bicycle - Unpaved:** Use of a nonmotorized bicycle on an unpaved, single or doubletrack trail.

**Interpretative/Nature:** Activity on trail that is self-guided with interpretive signs.

**Horseback:** Riding a horse on trail.

**Canoe/Kayak:** Non-motorized canoe or kayak in freshwater or saltwater. Trails should be marked. **Exercise/Jogging:** Generally conducted on trails with exercise (parcours) stations.

**Off Highway Vehicle:** Use of a motorcycle or all-terrain vehicle off-highway. Activity may be on unpaved roads or single track trails.

### **Beach Areas**

**Saltwater/Freshwater:** Number of beach areas.

**Length:** The total length of the beach areas.

**Width:** The total width of the beach areas.

### **Boat Ramps**

Please separate facilities by location in freshwater or saltwater. Please consider brackish water as saltwater.

**Boat Ramps:** Number of boat ramps in freshwater or saltwater. Please consider brackish water as saltwater.

**Ramp lanes:** Total number of lanes.

**Canoe/Kayak Launch:** Total number of launch sites. Can be both primitive and developed.

### **Marinas**

Please separate facilities by location in freshwater or saltwater. Please consider brackish water as saltwater.

**Marinas:** Number of marinas in freshwater or saltwater.

**Slips/Moorings:** Number of slips/moorings.

### **Fishing Facilities**

The facilities listed below should provide only fishing opportunities. Please separate facilities by location in freshwater or saltwater. Please consider brackish water as saltwater.

**Piers:** Total number of fishing piers and total length (minimum 300' for saltwater and 200' for freshwater).

**Boardwalks/Catwalks:** Total number & length of boardwalks and catwalks used specifically for fishing. Catwalks are commonly found along the partition on bridges.

**Jetties:** Length of jetties commonly used for fishing.

**Swimming Pools:** Note total number of outdoor swimming pools includes wading pools or splash playgrounds.

### **Outdoor Courts**

**Basketball:** Note number of goals

**Tennis:** Note the total number of individual outdoor tennis courts.

**Volleyball:** Note number of courts with nets; include sand volleyball courts.

**Racquetball/Handball:** Note outdoor courts used for racquetball or handball.

**Multipurpose:** Note the total number of outdoor courts used for multiple court activities.

**Pickleball:** Note the total number of individual outdoor pickleball courts.

### **Playing Fields**

**Football/Soccer:** Note the total number of fields used for football, soccer and rugby. Count each field only once even if it used for multiple field activities.

**Baseball/Softball Fields:** Combine the total number of baseball, softball, and little league fields with backstops. Count each field only once.

**Golf Courses:** Indicate number of each type of course and combine the total number of holes.

**9 Hole Regulation:** Par 34

**18 Hole Regulation:** Par 67

**Par 3/Executive Course:** Par ` 34 or ` 67

### **Other Facilities**

**Equipped Play Areas:** Playgrounds with play equipment. If equipment is spread throughout the park, count as one. If the equipment is placed in a distinct area, count each area.

**Recreation Centers:** Number of recreation centers on site with outdoor recreation facilities.

**Parking Areas:** Number of parking areas.

**Parking Spaces:** Number of parking spaces.

**Shooting Ranges:** Number of shooting ranges.

**Skate Parks:** Number of skate parks. If equipment is spread throughout the park, count as one. If the equipment is placed in a distinct area, count each area.

**Disc Golf:** Number of disc golf courses available

**Dog Parks:** Number of dog parks.

**Splash Pads:** Number of splash pads.
